Symposium topics will be of interest to contractors, technologists, engineers, and designers; and presentations will address: new wireless technologies and industry applications, the adoption of mobility, and the future of mobility. The topics will be addressed from the perspectives of: benefits and barriers of implementation, solutions currently available and results of real implementations, implications for the industry. Presentation will feature national and international experts in the research and development of mobility technologies, and regional champions in their application. General Overview

Communication needs are evolving and communication devices are becoming more personal, mobile and content-rich. The primary use of the Internet has expanded far beyond academics, and the borders between work and home, information and media are indistinguishable. The new generation of devices supports these changes, and standards to enable their operation. Users want access to corporate information anytime, anywhere and through the medium of their choice. Although wireless technologies have existed in some state for decades, there have been incredible developments at the end of the 20th century and the beginning of the 21st. The impact of wireless technology has been enormous around the world, resulting in major social and economic change.

Text Messaging is experiencing the greatest growth in mobile phone services, more growth than voicemail and call waiting. Cellular phones currently have numerous features allowing for increased functionality. Today 40% of people feel that cellular is an indispensable component of their lives. It has been estimated that at the end of 2002 there were approximately 1.4 billion mobile subscribers worldwide. In May 2003, Canadians sent more than 27 million text messages, a typical monthly total. This is an increase of 150% from the same month one year ago when approximately 18 million text messages were sent. Today handhelds are capable of much more than keeping track of meetings and contact information. They are capable of storing information the same as a personal computer and emailing this information wirelessly. It does not make sense in today's mobile world to be dragging around laptops since many people work standing up. Handhelds are simple to use, small and light, affordable, compatible, and they have abundant software.

A panel discussion will be held to gain further feedback from symposium participants on the examples and technologies presented and initialize connections between industry representatives and the resources available to exploit the technologies. Panel speakers will include representation from researchers, industry representatives, and technology suppliers. The Provincial Accreditation Board (PAB) of the New Brunswick Society of Certified Engineering Technicians and Technologists (NBSCETT) and the Canadian Technology Accreditation Board (CTAB) of the Canadian Council of Technicians and Technologists (CCTT) are seeking technology professionals from industry, government and academic sectors to serve as team leaders and program evaluators to assist in accrediting Applied Science and Engineering Technology programs at Canadian colleges/ Canadian Forces Schools of Miliary Engineering..

Participation in the national accreditation process is a joint effort carried out by CTAB, the constituent member associations/societies of the CCTT and other accreditation partner organizations such as the Canadian Society for Chemical Technology (CSCT). This activity depends on the efforts of motivated and qualified professionals and the support provided by their employers.

Volunteering time to the National Accreditation Program provides certified members of the profession the opportunity to contribute to the achievement of high quality educational standards of applied science and engineering technology programs.

CTAB, in partnership with NBSCETT and sister provincial associations and societies of CCTT, has accredited approximately I58 programs at 39 institutions across the country.

Application/Participation for Program Evaluator

Evaluator candidates are required for accrediting programs in all thirteen global disciplines of applied science and engineering technology training programs and certification. Participation in the national accreditation process by talented certified professionals will ensure that the requirements of industry and academics are addressed. Employer sponsorship and support is crucial for the recruitment of team leaders and program evaluators. Expenses related to training and accreditation visits are reimbursed by CM/CTAB. Prior to participation in accreditation visits, selected team leaders and program evaluators are required to attend a CM sponsored one-day training seminar.




